

Guidelines for Authors

There are no fees payable to submit or publish in this Journal.

As part of the submission process, you will be required to warrant that you are submitting your original work, that you have the rights in the work, and that you have obtained and can supply all necessary permissions for the reproduction of any copyright works not owned by you, that you are submitting the work for first publication in the Journal and that it is not being considered for publication elsewhere, and has not already been published elsewhere.

1. Peer Review Policy

Journal of Digital Technology and Society adheres to a rigorous double-anonymize reviewing policy in which the identity of both the reviewer and author are always concealed from both parties.

1.1 Authorship

All parties who have made a substantive contribution to the article should be listed as authors. Principal authorship, authorship order, and other publication credits should be based on the relative scientific or professional contributions of the individuals involved, regardless of their status. A student is usually listed as principal author on any multiple-authored publication that substantially derives from the student's dissertation or thesis.

1.2 Acknowledgements

All contributors who do not meet the criteria for authorship should be listed in an Acknowledgements section. Examples of those who might be acknowledged include a person who provided purely technical help, or a department chair who provided only general support.

Please supply any personal acknowledgements separately to the main text to facilitate anonymous peer review.

1.3 Writing assistance

Individuals who provided writing assistance, e.g., from a specialist communications company, do not qualify as authors and so should be included in the Acknowledgements section. Authors must disclose any writing assistance – including the individual's name, company, and level of input – and identify the entity that paid for this assistance. It is not necessary to disclose the use of language polishing services.

1.4 Funding

Journal of Digital Technology and Society requires all authors to acknowledge their funding in a consistent fashion under a separate heading.

1.5 Declaration of conflicting interests

Journal of Digital Technology and Society encourages authors to include a declaration of any conflicting interests.

Please ensure that a ‘Declaration of Conflicting Interests’ statement is included at the end of your manuscript, after any acknowledgements and prior to the references. If no conflict exists, please state that ‘The Author(s) declare(s) that there is no conflict of interest’.

1.6 Research data

Journal of Digital Technology and Society encourages authors to share their research data in a suitable public repository subject to ethical considerations and where data is included, to add a data accessibility statement in their manuscript file. Authors should also follow data citation principles.

2. Submission Types and Format

2.1 Original research

This category of submission includes articles that are underpinned by theoretical, methodological, conceptual, or philosophical foundations. The word count can range between 8000 – 10000 words.

2.2 Open forum

The **Open Forum Section** may also include strategic ideas, critical reviews, and potential implications for society of current research. The word count ranges between 5000 – 7000.

2.3 Short essays

Short Essays are critical or analytical column on trends in technology, arts, science, and society, commenting emphatically on issues of concern to the research community and broader society. The word range is 2000 – 3000. This section also encourages an author to submit philosophical, theoretical, and conceptual comments.

2.4 Review essays

Review essays are written by critically analysing a scholarly work. This should include dissection of the core argument made by the work chosen and provide its implications for further research or application. The word count for this section would be 2000- 2500.

2.5 Book reviews

Book reviews should range between 1000 – 1500 words

3. Structure of the manuscript

1. Abstract (200-300 words)
2. Keywords
3. Introduction should contain the main arguments made in the paper
4. Body of the paper

Authors are free to be creative in this section but must stick to the academic standards

5. Follow APA style formatting. Intext citations are required

Book review format

1. Heading will be the book title followed by the author's name, publisher, and year of publication
2. The review will have citations in APA format (intext citations)

4. Publishing policies

4.1 Publication ethics

The Journal committed to upholding the integrity of the academic record. We encourage authors to refer to the Committee on Publication Ethics' [International Standards for Authors](#).

4.1.1 Plagiarism

Journal of Digital Technology and Society takes issues of copyright infringement, plagiarism, or other breaches of best practice in publication very seriously. We seek to protect the rights of our authors and we always investigate claims of plagiarism or misuse of published articles. Equally, we seek to protect the reputation of the Journal against malpractice. Submitted articles may be checked with duplication-checking software. Where an article, for example, is found to have plagiarized other work or included

third-party copyright material without permission or with insufficient acknowledgement, or where the authorship of the article is contested, we reserve the right to take action including, but not limited to: publishing an erratum or corrigendum (correction); retracting the article; taking up the matter with the head of department or dean of the author's institution and/or relevant academic bodies or societies; or taking appropriate legal action.

4.1.2 Prior publication

If material has been previously published it is not generally acceptable for publication. However, there are certain circumstances where previously published material can be considered for publication.

4.2 Contributor's publishing agreement

Before publication, CDPP requires the author as the rights holder to sign a Journal Contributor's Publishing Agreement. CDPP's Journal Contributor's Publishing Agreement is an exclusive licence agreement which means that the author retains copyright in the work but grants CDPP the sole and exclusive right and licence to publish for the full legal term of copyright. Exceptions may exist where an assignment of copyright is required or preferred by a proprietor other than CDPP. In this case copyright in the work will be assigned from the author to the society.

5. Information required for completing your submission

You will be asked to provide contact details and academic affiliations for all co-authors and identify who is to be the corresponding author. These details must match what appears on your manuscript. The affiliation listed in the manuscript should be the institution where the research was conducted. If an author has moved to a new institution since completing the research, the new affiliation can be included in a manuscript note at the end of the paper. At this stage, please ensure you have included all the required statements and declarations and provided any additional supplementary files (including reporting guidelines where relevant).

5.1 Permissions

Please also ensure that you have obtained any necessary permission from copyright holders for reproducing any illustrations, tables, figures, or lengthy quotations previously published elsewhere.

6. On acceptance and publication

6.1 CDPP production

Your CDPP Production Editor will keep you informed as to your article's progress throughout the production process. Proofs will be made available to the corresponding author via email, and corrections should be made directly or notified to us promptly. Authors are reminded to check their proofs carefully to confirm that all author information, including names, affiliations, sequence, and contact details are correct, and that Funding and Conflict of Interest statements, if any, are accurate.

6.2 Online First publication

Online First allows final articles (completed and approved articles awaiting assignment to a future issue) to be published online prior to their inclusion in a journal issue, which significantly reduces the lead time between submission and publication.

6.3 Access to your published article

CDPP provides authors with online access to their final article.

6.4 Promoting your article

Publication is not the end of the process! You can help disseminate your paper and ensure it is as widely read and cited as possible. CDPP promotes the journal articles on social media, and circulates the journal to all the partner organisations.
